## **Program Details**

# • Arrival & Departure

Students are responsible for arranging and purchasing their airfare. During the spring pre-departure classes, you will be assisted with information on program flight itineraries and how to book flights for traveling together. **Do not purchase your flight without prior approval from the Director of Study Abroad (trulaskeabroad@missouri.edu).**Failure to provide a paid ticket itinerary by March 1, 2026, may result in being dropped from the program.

The program ends upon check-out on March 27, 2026

Note: The Study Abroad Program and MU will not be responsible for any expenses incurred (including lodging) due to delays or cancellations of flight arrangements made by the student. Students concerned about the costs they might incur due to flight delays or cancellations are encouraged to purchase travel insurance.

# **Course Offering and Prerequisites**

### Course Overview:

This is an introductory international business course open to students of all backgrounds of study. The emphasis will be on understanding various issues in international business with a focus on the New York City melting pot of culture, business, supply chain, and trading relationships in the global economy.

# Undergraduate – FIN 4185: Special Topics in Finance – International Business, New York Class #TBA

3 credit hours; graded S/U; Instructor TBA; no prerequisites Consult with your academic advisor about how this course would satisfy your degree requirements.

Note: these courses were designed by the Registrar's Office as spring courses. Educational fees for three credit hours are costs you normally see on your spring bill. Non-resident students will pay the usual non-resident fees.

- The course will be conducted in two parts:
  - 1. Four pre-departure classes at MU will lay the groundwork for principles of international business with focus on the New York City melting pot of culture, business, supply chain, and trading relationships in the global economy.
  - 2. A travel experience, which includes experiential learning exercises, group discussions and presentations, and company visits. The company visits are an essential part of the learning experience and allow students to discuss with company managers international business strategies in marketing, finance, and management. The schedule while on location allows free time for sightseeing and visiting local cultural and historic sites.
- Pre-departure classes at MU:

Pre-departure classes begin **January 27, 2026**, in Cornell Hall and you are required to enroll before the first pre-departure class to go on the program.

Note: You are required to attend every pre-departure class to prepare for the program, or you will not be allowed to participate in the program. Special circumstances may allow flexibility on this requirement but it must be approved by the program director before the class absence. If you are dropped from the program due to non-attendance, you will be subject to the penalties listed under the Withdrawal Procedure & Penalties portion of this document.

### **Estimated Budget**

The following estimated budget may be used for planning purposes:

Note: The educational fees above will be billed to the student account on approximately February 2026. Please note that these are estimates; Non-resident students will pay non-resident fees.

- Expenses **Included** in Program Fee
  - All airport transfers and ground transportation for company visits
  - Lodging for the trip duration, including all breakfasts
  - o Entry fees into cultural visits
  - Two group dinners
  - o Public Transportation Card
  - o Program water bottle and graduation cord
- Expenses Not Included in Program Fee
  - Airfare from MO to NY
  - Meals not included in the program fees, as noted on the itinerary
  - Educational fees tuition and fees will be billed the same as a 3-credit hour undergraduate course taken in Spring 2026 unless student is taking less than 18 credit hours per tuition model
  - Optional personal expenses such as souvenirs, personal items, social outings, activities or excursions such as outdoor adventures or cultural visits, and city transportation to participate in non-program activities (subway, taxi, bus fares).
  - Additional insurance for trip modification, cancellation, or interruption due to health, safety, or similar concerns.

## **Paying to Study Abroad**

Scholarships:

The program application and the scholarship application will be one packet students will submit prior to **November 21, 2025**. Scholarship decisions will be made on a rolling basis.

### Withdrawal Procedure & Penalties

The withdrawal fees do not increase until November 17, 2025. You must email the Student Service Coordinator (TrulaskeAbroad@missouri.edu) documenting withdrawal from the program AND return to the online application to change the status to **WITHDRAWAL: Declined**. The following schedule indicates program withdrawal fees that will be billed to the student account:

Note: The date of withdrawal notification is the date the notification email is sent to the Student Services Coordinator. Depending on the date you withdraw, the Study Abroad Office may not be able to get a refund from the vendor; your refund will be relative to the costs that can be recovered. If you have not been billed the program fee at the time of your withdrawal, you will be billed for any cancellation fees charged to the program.

### **Visas & Travel Documents**

In the United States, you need a valid U.S. government-issued photo ID or a passport from your country of
origin to travel through security. You must show that the name on your boarding pass matches the legal name
on your unexpired government-issued ID.

**IMPORTANT:** If you are a student with a disability and anticipate requesting accommodations while studying abroad, we encourage you to notify the MU Office of Disability Services as early as possible (http://disabilityservices.missouri.edu). Early notification is essential to allow us time to ensure that appropriate arrangements and reasonable accommodations can be provided, both by the program and our Study Abroad partner organizations.

### **Program Cancellation Policy for Student Financial Liability**

Spring Break Study Abroad

- Cancellation of the program due to circumstances beyond the control of the University of Missouri
- A decision by the University, in its sole discretion, that cancellation of the program is appropriate based on health, safety, or similar circumstances
- My inability to participate in or complete the program due to circumstances beyond the control of the University
  of Missouri
- My dismissal from the program

I understand that in any of these circumstances, I will be refunded only those costs that can be recovered by the University of Missouri or the University's partner program. If I have not been billed the program fee at the time of my withdrawal, I understand that I will be billed for any cancellation fees charged to the program.

The itinerary of this program may be modified by the Trulaske College of Business and/or the University of Missouri due to health, safety, or similar concerns. The withdrawal fees listed above will apply to students if this occurs. Transportation change fees and expenses will be the responsibility of the student.
