KEY FUNDRAISING TEAM ACCOMPLISHMENTS:

- **Gifts and Endowments**: Have helped build/manage more than \$3.2 million in distributable funds and more than \$8 million in endowment funds. Have also helped facilitate estate gift commitments from alumni for a wide variety of support, including faculty support and scholarships.
