Robert J. Trulaske (True-Lask), Sr. Scholarships in Business are awarded to incoming freshman students pursuing degrees from MU's Robert J. Trulaske, Sr. College of Business. This scholarship assists very good students who do not meet the qualifications for Bright Flight or other excellence-based scholarship programs such as the Curator, Excellence and Brooks Scholarships. The scholarship provides \$9,500 per year and is renewable for a maximum of four years (eight semesters).

First preference for selection of recipients is given to children of full-time active employees of True Manufacturing Company and other directly related companies. Additional preference is also given to students demonstrating financial need (you must fill out the FAFSA) and students graduating in the upper two-thirds but outside the top ten percent of their high school class. Special emphasis is placed on students who have exhibited business interests through work experience and/or other related activities. Applicants should also show evidence of leadership abilities and other activities.

In accepting a Trulaske Scholarship, all recipients must sign and adhere to the conditions detailed in the Statement of Understanding. Violating this agreement could lead to the immediate revocation of the scholarship.
